### Perú (Huachuma, Puno and Cusco) Trip Cost

The October 2026 trip cost is \$4,520.00 USD with double occupancy. Private rooms might be available in Marastambo, Cusco, Aguas Calientes and Puno Hotels for an additional cost of \$800. Private rooms on Amantaní Island are limited and can be requested when we arrive, at no extra cost. **Please send me your request no later than 7/20/26.**

**SPECIAL DISCOUNT: \$350 OFF**

**The price is \$4,170 (with Hotel Double Occupancy) if you pay in full by July 20, 2026.**

**Reservation & Deposit:** The deadline for your deposit of \$2,000.00 USD along with your Trip Application Form (it will be emailed to you or mailed if requested) is **Monday, July 20, 2026**. The full balance of the trip is due on **Monday, September 21, 2026**. You may pay the full balance of the trip at the time you make the deposit. If the full balance is not received by Monday, September 21, 2026, we reserve the right to cancel your reservation according to the cancellation and refund policies identified below.

All payments are made by money orders or checks made payable to Free Your Spirit. **By request only:** online payments are made via PayPal or Venmo, which includes a 2.9% (or higher depending on your location) + \$0.30 convenience fee. You can also pay through Zelle with no fees attached or you can make a direct deposit to Free Your Spirit Account, please call Mariscela at 530-863-0003.

**VERY IMPORTANT: Cancellation & Refund Policy:** All cancellations and refund requests must be made in writing to Free Your Spirit, Mariscela Alvarez, P.O. Box 1204, Nevada City, CA, 95959

We will refund a total of \$500 of the initial deposit if the participant cancels before Monday, July 20, 2026, within 30 days of the return date on November 6<sup>th</sup>. No refunds will be made after Monday, July 20, 2026, on deposits or balance amounts.

**Airline Tickets:** If you're fully committed to travel with us, I'll send you the suggested fly itinerary to check prices and availability. I recommend traveling with LATAM Airlines, but American and Avianca Airlines are also available. Feel free to start researching but **wait to purchase your tickets until I advise you to do so**, as I need a minimum of 6 participants to make this trip possible. If you want to receive assistance and

good prices, I can send you the information of the Travel Agent I work with, who is familiar with our itinerary.

**Travel Insurance:** We strongly recommend purchasing “Cancel Anytime” Travel Insurance to cover any unforeseen risks that traveling might involve, especially to a foreign country. - Passport Validity: Must have six months’ validity at time of entry.
- Blank Passport Pages: One page required for entry stamp.
- Tourist Visa Required: **Free**, issued at the port of entry.
- Currency Restrictions for entry and exit: \$30,000 USD. More than \$10,000 USD must be declared upon entry.

**Trip Cancellations & Changes:** We reserve the right to change our trip itinerary or cancel the trip without notice due to forces beyond our control (acts of nature, war, labor strikes, road conditions, insufficient number of participants or other conditions.) A trip cancellation due to insufficient numbers would normally occur by the date of the deposit, unless acts of nature, war strikes, or other events impede our departure causing large numbers of participants to cancel participation on the journey in the last days before departure.

If we are unable to provide you with another trip that is satisfactory, all monies paid will be refunded and shall constitute full settlement with you. We are not responsible for any additional expenses that may be incurred because of cancellation, sickness, travel delays, and/or flight cancellations, including non-refundable lodging deposits or non-refundable “advance purchase” airline tickets. A participant might be asked to leave the trip if a guide feels that their continuing participation may prove harmful to that person or to the well-being of the other participants. We are not responsible for any additional expenses incurred by such participants.

**Personal Responsibility:** Participants are responsible for ensuring this trip suits his/her abilities, level of fitness and health, psychological and emotional stability in any special condition and diet. In addition, the destinations are high altitude – if you are concerned about your health at these locations, check with your physician. Participants must provide us with a signed Statement of Psychological and Health Condition prior to departure.

If you choose to have a roommate and during the trip either you or your roommate move to a private room regardless of the circumstances causing the separation, you, and your roommate will be individually responsible for the extra cost of each private room. The cost might be prorated depending on each situation.
